Rick, Chuck, Wendy, Louis, Pam, Kristy, Roger, Trevor, and James,

Each one of you has actively participated in concealing child abuse and shielding Thomas Neal.

I am writing with utmost urgency and seriousness regarding my previous request. I must receive a response by today, no later than 5 PM. I want to make it unequivocally clear that I am fully committed to ensuring the upcoming hearing on April 8th is conducted in the public eye. To this end, I will contact parents, the media, and any necessary platforms to guarantee transparency and openness during the proceedings.

The severity of this situation cannot be overstated, especially in light of Louis's threats to incarcerate me for safeguarding my children and myself against the involvement of two psychologists, who have been officially deemed unethical by legal benchmarks. This alarming development is further compounded by the inexplicable recommendation of Roger Hatcher for my evaluation—a direct violation of explicit judicial directives. Judge Felice has categorically banned Hatcher from participating in any capacity that requires court engagement due to serious concerns regarding his suitability and ethics. Despite this explicit prohibition, Hatcher's proposed involvement undermines the legal process. Should you decide to proceed with the hearing scheduled for the 8th, let me be unequivocally clear: in the event of a trial, I will not face this challenge in isolation. I am committed to mobilizing a significant presence to ensure the hearing is conducted openly and lawfully, with a firm stance against those who have violated our trust and legal standards. I would like to have a clear and immediate response by the end of today, as this will allow me to initiate the necessary legal preparations and motions. My objective is to foster unprecedented transparency and public involvement in the trial process, ensuring that justice is not only done but seen to be done by all concerned parties.

Despite the odds, I have gained momentum and am fully prepared to defend myself and my children's interests. The disparity in numbers doesn't seem to deter me; your underestimating my dedication to my children only fuels my determination.
